



## QR-Hosted Events | Queensland Raceway 2025 Toyota 86 promotional giveaway supported by Llewellyn Motors (known as the "Queensland Raceway Llewellyn Motors Giveaway")| Terms and conditions

- 1) **Promoter**: The Promoter is Queensland Raceway Operations Pty Ltd, ABN: 11 656 244 843 Champions Way Willowbank 4306, Phone: 07 5461 9100, Email: admin@gldraceways.com.au
- 2) Acceptance: Information regarding prizes and how to enter forms part of these terms and conditions. Participation in the giveaway is deemed acceptance of these terms and conditions. If the winner does not accept these terms and conditions, the prize will be forfeited. Entries not completed in accordance with these terms and conditions are ineligible.
- 3) **Eligibility**: Subject to clause 5, the giveaway is open to persons (i.e. individuals) who meet the following criteria:
  - a. Australian residents only.
  - b. All persons that have pre-purchased a spectator ticket through the Queensland Raceway website (qldraceways.com.au) to a QR-Hosted Event during the Entry Period.
  - c. All persons that have entered (as a driver) through the Queensland Raceway website (qldraceways.com.au) a QR-Hosted Event during the Entry Period.
  - d. Full compliance with these terms and conditions and all applicable laws and regulations.
- 4) **QR-Hosted Event**: For the purposes of these terms and conditions a "QR-Hosted Event" means any event hosted/promoted/organised by Queensland Raceway.
- 5) **Disqualified participants**: The following persons are disqualified from participating in the giveaway:
  - a. All persons under the age of 18 years (as at the time of the applicable QR-Hosted Event).
  - b. Directors, management, employees, officers and contractors (and their immediate families) of the Promoter, its related bodies corporate, prize suppliers and agencies associated with this giveaway are ineligible to enter.
  - c. Disqualified participants must not enter the giveaway.

- 10) **Entry period**: The giveaway period for the Queensland Raceway Llewellyn Motors Giveaway begins on 1<sup>st</sup> January 2025 at 8:00am AEST and closes on 20<sup>th</sup> December 2025 at 12.30pm AEST (the "Entry Period"). Any change to the giveaway's closing date will be notified on the Queensland Raceway website.
- 11) **Selection of winner**: The winning entry will be selected at random (i.e. by chance) from a draw of all valid entrants. The draw will take place at the Queensland Raceway offices at 133 Champions Way, Willowbank in the state of Queensland (the "**QR Offices**") on Sunday 21<sup>st</sup> December 2025 at 1.00pm AEST. Any change to this time will be notified on the Queensland Raceway website.
- 12) **Physical presence**: Each entrant must be physically present on site at the QR Offices when the draw is taking place to be eligible to win.
- 13) **Notification of winner**: The winner's name will be publicly announced immediately following the conclusion of the draw. The winner will be contacted on the phone number linked to their entry within 5 minutes of the conclusion of the draw (note: only 2 attempts to call the winner to the phone number provided will be made). Personal information of the entrant (including their phone number) is presumed to be true and Promoter takes no responsibility for verifying the phone number provided.
- 14) **Positive obligation of winner**: The winner must make himself/herself known to a staff member of the Promoter immediately after the winner is publicly announced and they must provide proper photo identification (e.g. driver's licence, passport). Failure to respond within 15 minute time period (time being of the essence) may result in disqualification, and an alternate winner may be selected, by the Promoter completing a redraw at the QR Offices.
- 15) **Publicity**: The winner must, at the Promoter's request, participate in all promotional activity (such as publicity and photography) surrounding the winning of the prize, free of charge, and they consent to the Promoter using their name and image in promotional material.
- 16) **Promoter's discretion**: Entries will be reviewed by the Promoter. The Promoter reserves the right to verify the validity of entries. Entries may be accepted or rejected at the Promoter's absolute discretion. Entries deemed to not comply with these conditions of entry will be deemed invalid and the entrant will not be eligible to win the prize.
- 17) **No responsibility**: The Promoter accepts no responsibility for late, lost, incomplete, incorrectly submitted, delayed entries, claims or correspondence whether due to error, omission, transmission interruption, communications failure, or any technical difficulties or periods of unavailability of the entry mechanism during the Entry Period. The Promoter has no control over networks or lines and accepts no responsibility for any problems associated with them, whether due to traffic congestion, technical malfunction or otherwise. The Promoter is not liable for any costs incurred, responses received or any other consequences of user error.
- 18) **Prize**: The prize is a new 2025 GR Toyota 86. This prize is valued at approximately \$62,000 including GST (retail value), as at the commencement date of this giveaway. The prize however excludes any and all on-road costs, registration paperwork and fees, registration duty and insurances (including any compulsory third party insurance), and the winner acknowledges and agrees that he/she shall be solely responsible for all of these items and costs. Ongoing service and maintenance is the sole responsibility of the winner. The Promoter and partners will do their best to ensure prizes are delivered promptly. Further, all prizes are subject to the conditions imposed by the Promoter's partners (including in respect of the giving of any warranties).
- 21) **Prize delivery**: Prize delivery will occur at the Queensland Raceway motorsport venue, and it is the winner's responsibility to collect their prize from the Queensland Raceway motorsport venue at the date and time as nominated by the Promoter.
- 22) Further agreements: The Promoter reserves the right to request winners to sign any relevant forms or agreements that the Promoter (or its associated agencies/companies or partners) deem necessary, and to provide proof of identity and proof of residency in order to claim a prize.
