 - (a) Purchase a spectator ticket to a QR-Hosted Event via the official Queensland Raceway website; or
 - (b) Enter as a driver in a QR-Hosted Event; or
 - (c) Purchase a new vehicle from Llewellyn Motors; or
 - (d) Spend a minimum of \$500 (including GST) on car service, parts or accessories at Llewellyn Motors.

5. QR-Hosted Event is defined as any event hosted, promoted or organised by Queensland Raceway.
